- with note prot. n. 2132 of the 15.11.2023 the Prof. Astrid Gamba requested activation for a junior fellowship in research activities for the Department of Economics in the Academic Recruitment Fields 13/A1 -Economics, entitled: "Experiments on the effects of social preferences, self and social-image concerns, and moral accounting on economic decisions" lasting 12 months, in which he indicated the title of PhD as a non-mandatory requirement;
- with decree rep. n. 241 of the 20.12.2023 has been published procedure for a junior fellowship in research activities for the Department of Economics in the Academic Recruitment Fields 13/A1 -Economics, entitled: "Experiments on the effects of social preferences, self and social-image concerns, and moral accounting on economic decisions" Code DIECO2023-ADRJ006, expiring February 29, 2024;
- The University Regulation for the awarding of research grants, in compliance with the provisions of Article 22 of Law No. 240 of December 30, 2010, regarding research grants, paragraph 4, letter b), Article 14, paragraph 2, provides that: "Candidates eligible for the Junior Research Grants selection must hold a Ph.D.

- with note prot. number 377 dated February 27, 2024, Professor Astrid Gamba requested to amend the notice by including, as a mandatory requirement, the title of Ph.D., and to extend the deadline to allow other candidates to participate in the public selection;
- Given article no. 22 of the Law no. 240 of 30 December 2010, on research grants;
- having seen the art. 21 octies of Law 7 August 241 1990 which regulates the annullability of administrative measures;
- Given the Regulations for the Assignment of Research Grants (hereafter the Regulations) issued by Rectoral Decree no. 903 of July 24th 2013, latest amendments issued by Rectoral Decree no. 347 of April 28th 2021, effective as of May 14th 2021;
- acknowledged the request prot. n. 2132 of the 15.11.2023 of the Prof. Astrid Gamba of activation for a junior fellowship in research activities for the Department of Eco-nomics in the Academic Recruitment Fields 13/A1 –Economics, entitled: "Experiments on the effects of social preferences, self and social-image concerns, and moral accounting on economic decisions" Code DIECO2023-ADRJ006, in which he indicated the title of PhD as a non-mandatory requirement;
- having noted that the public selection notice for the awarding of the research grant in question approved with decree rep. n. 241 of the 20.12.2023 due to a clerical error, it included the title of research doctor as an optional requirement;
- having acknowledged that the University Regulations for the awarding of grants for research activities, in art. 14 paragraph 2 provides that: "PhDs in the scientific area connected to the research activity covered by the collaboration can participate in the selection for the Junior Research Grants", thus requiring the title of PhD, a mandatory requirement;
- having read the request of prof. Astrid Gamba prot. n 377 of the 27.02.2024 in which, following the modification of the mandatory requirement, the extension of the notice is requested to allow other candidates in possession of the requirement to submit an application;
- Considered necessary to correct the selection procedure for a junior fellowship in research activities for the Department of Economics in the Academic Recruitment Fields 13/A1 –Economics, entitled: "Experiments on the effects of social preferences, self and social-image concerns, and moral accounting on eco-

nomic decisions" – Code DIECO2023-ADRJ006, lasting 12 months, under the guidance of Head of Research, Prof. Astrid Gamba, issued with Decree Rep. n. 241 of the 20.12.2023, indicating as a mandatory requirement the title of PhD in Economics, pursuant to art. 14 of the University Regulations for the awarding of grants for research activities, in order to amend the material error relating to the research doctor requirement initially requested as an optional and non-mandatory requirement, thus remedying the administrative provision;

Considered appropriate to extend the deadline of the thus corrected notice for the same period as the amended notice in order to guarantee the same rights to potential future candidates;

#### **DECREE**

- 1. To rectify the selection procedure for a junior fellowship in research activities for the Department of Economics in the Academic Recruitment Fields 13/A1 -Economics, entitled: "Experiments on the effects of social preferences, self and social-image concerns, and moral accounting on economic decisions" Code DIECO2023-ADRJ006, lasting 12 months, under the guidance of Head of Research, Prof. Astrid Gamba, issued with Decree Rep. n. 241 of the 20.12.2023, indicating as a mandatory requirement the title of PhD in Economics, pursuant to art. 14 of the University Regulations for the awarding of grants for research activities;
- 2. to extend the deadline for the public selection notice to **27.04.2024**:
- 3. to instruct the Administrative Secretariat of the Department of Economics with the execution of this provision which will be registered in the general repertoire of decrees.
