FURTHER INFORMATION	Restricted access degree program, with admission based on a "first come, first served" criterion according to the chronological order of application submission. For the academic year 2024/2025, there are 220 available seats for the Bachelor's Degree in Economics and Management of Innovation and Digital Sustainability, which will be distributed as follows: 200 seats reserved for Italian citizens, European Union citizens, and non-EU citizens legally residing in Italy, and 20 seats reserved for non-EU citizens residing abroad, including 5 seats reserved for Chinese citizens residing abroad participating in the Marco Polo and Turandot Project. Detailed participation terms will be outlined in a notice published at the beginning of July. Registrations will open, tentatively, in mid-July 2024.
	The program is delivered in Italian. Classes are held in the evening and/or Saturday mornings.
	In accordance with Ministerial Decree 270/2004, although the course is designed to be accessible to students with basic skills common to all high school diplomas, students enrolled in the first year of the Integrated Study Course in Economics and Management of Innovation and Digital Sustainability (including those who have transferred internally, transferred from another university or have shortened their academic career) must take a non-selective test to assess their initial level of knowledge in basic mathematics. The test is not mandatory or selective for enrollment purposes. Students who apply for a transfer or come from another university in order to enroll in the first year must also take the test, unless they have already passed a Mathematics exam in their previous course of study, even at another university.
ADMISSION MODE, INITIAL KNOWLEDGE ASSESSMENT, AND ADDITIONAL EDUCATIONAL OBLIGATIONS RECOVERY (OFA)	The test, consisting of multiple choice questions, focuses on basic quantitative knowledge (polynomials, algebraic equations and inequalities, analytical geometry) and is administered through the e-learning platform, following the procedures and deadlines specified on the dedicated detail page.
	To pass the test, students must correctly answer at least 50% of the questions. On the other hand, if the correct answers fall below this threshold, the student will be assigned an Additional Training Obligation (OFA), which must be fulfilled by passing the test in one of the subsequent sessions and in any case within the first year of the course, according to the timetable that will be published on the dedicated webpage.
	In order to help students prepare and pass the test, the University Orientation Office, in collaboration with the Study Course, organizes a Preparatory Mathematics Course, which takes place between the end of August and mid- September, before the start of classes. This course is aimed at students who wish to strengthen their previous skills before taking the test.



	For the fulfillment of the OFA, the Study Course provides tutoring services for students, where quantitative tutors are available to help students with specific difficulties. https://www.uninsubria.it/servizi/tutti-i-servizi/tutorato-dieco.
	The additional training requirement (and consequently the verification of initial preparation) is considered fulfilled if, by September of the year of first enrollment:
	1. a grade of at least 12/30 has been achieved in a test, even partial, of the Mathematics I exam (ECO0349);
	or
	2. at least 30 CFU related to first-year courses have been obtained (25 CFU for part-time students).
	If the training requirement is not met, the student will be enrolled in the academic year 2024/2025 as a "repeating" first-year student.
	Students are allowed to be simultaneously enrolled in two degree programs according to the provisions of Law No. 33 of April 12, 2022 and the relevant implementing decrees. A special Commission will assess the requests and compliance with the constraints and requirements provided by the regulations.
POSSIBLE TRAINING ACTIVITIES LEADING UP TO THE ASSESSMENT OF INITIAL KNOWLEDGE.	For first-year students, in order to facilitate passing the knowledge assessment test and begin the university journey without any educational obligations, it is recommended to attend the Mathematics Pre-course. 1. Hours delivered in person.

2. Hours delivered via telematic mode. Telematic teaching will be delivered, for a share of ECTS/hours not less than 60%, through synchronous live streaming video lessons and, for a share not exceeding 40%, through materials available on the e-learning platform for asynchronous use such as: recorded lessons, video pills, case studies/enrichment materials, assignments, group work, self-assessment tests, glossaries, forums, etc. 3. Hours delivered through telematic mode, through live streaming video lessons.



# III. RULES ON TRAINING PATH

At the time of enrollment, the student can choose between full-time and part-time commitment. The choice can be changed in the following years, but within the last year of the current enrollment. The choice cannot be reversed during the academic year.

Also at the time of enrollment, the student must choose to enroll in one of the two degree classes for which the study program is activated (L-18 - Economics and Business Management Sciences and L-33 - Economic Sciences), in order to choose the class within which he or she intends to obtain the degree. This choice must be confirmed or changed at each subsequent enrollment, becoming final at the time of enrollment in the third year (fourth year for part-time students).

## PROPAEDEUTICITY

The propedeutic courses serve the dual function of directing students towards a gradual and harmonious learning of the course content and of enforcing respect for graduation timelines as much as possible

# FULL-TIME COMMITTED STUDENTS

The transition from the first to the second year is subject to the achievement of at least 30 CFU by the September 2025 exam session (included). A student who achieves 30 CFUs but has not passed all exams in the first year can enroll in the second year and take the relative exams, respecting the following prerequisites between exams in the first and second year.

To pass from the second to the third year, it is required to pass all exams from the first year and achieve at least 30 ECTS from the second year by the September 2026 exam session (included).

## PART-TIME DEDICATED STUDENTS

The transition from the first to the second year is subject to obtaining at least 25 CFU by the September 2025 session (included). A student who achieves 25 CFU, but has not passed all exams in the first year, can enroll in the second year and take the respective exams, respecting the following prerequisites between exams of the first and second year:

Unsustainable Teaching (2nd year)	If you have not passed the teaching of the 1st year:
- Accounting and balance sheet	- Management

For the transition from the second to the third year, passing all exams of the first year and obtaining at least 18 CFUs by the September 2026 exam session (inclusive) is required. Furthermore, the following prerequisites must be met in order to take the exam:

## **RECOGNITION OF LANGUAGE AND COMPUTER CERTIFICATIONS**

Students who already hold a certification attesting to level B2 proficiency in the English language can apply for validation at the Student Office.

Certifications obtained in the last five years from the date of validation application are eligible for recognition (as decided by the Department Council on May 28, 2018 and subsequently confirmed on May 27, 2019), with the exception of IELTS, TOEFL IBT, TOEFL CBT, and TOEFL PBT certifications which, by law, have a validity of two years.

Recognition of other certifications

Students holding the Certification "e4Job - Digital Culture for Work" can apply for validation at the Student Office for the recognition of the exam "Information Systems and Soft Skills for the Digital Enterprise" (6 ECTS credits). An eligibility will be granted upon recognition.

## **RECOGNITION OF PROFESSIONAL SKILLS OR EXAMS PASSED IN PREVIOUS CAREER**

In case of enrollment with a request for recognition of previous career, the Department, taking into account the specific educational objectives of the study program and, in any case, respecting the educational constraints established by the current Teaching Regulations of the course itself, ensures the recognition of the highest possible number of ECTS credits. For the purpose of recognition, interviews or examination tests may be carried out to assess the actual level of knowledge possessed.

Some exams may be partially recognized; in this case, the student will be asked to complete the missing part of the program, following an agreement with the teacher in charge of the course. Supplementary exams can be taken, after the student enrolls, only in the session dedicated to exams and not during partial examination sessions.

The Department considers ECTS credits acquired more than 10 years prior to the validation request as outdated, therefore in this case it does not adopt recognition resolutions, nor verification systems and/or supplementary exams.

Thanks to the Convention in place with the Order of Chartered Accountants and Accounting Experts of Varese, CLEMISDI graduates (who have included the exam of Programming and Control or Management Control in their study plan) are exempt from the first test of the State Exam for access to the profession of Accountant.

Furthermore, thanks to the agreements in place with the Order of Chartered Accountants and Accounting Experts of Varese and with the Order of Labor Consultants of Varese, it is possible to carry out a professional internship for 6 months in the final year of the course, under the supervision of a professional registered with the Order. The internship through the Order of Chartered Accountants and Accounting Experts of Varese is only allowed for CLEMISDI students who have included the exam of Programming and Control or Management Control in their study plan.

**FREQUENCY OBLIGATIONS: NOT SPECIFIED Frequency, although not mandatory, is strongly recommended.** It is worth noting that it is possible to attend classes even if the enrollment process has not been completed yet. However, in order to access educational services such as e-learning tools, email, and the ESSE3 application for managing university careers, attendance is required. Translate to English: university credentials. It is therefore advisable to proceed quickly with the enrollment, so that the process can be completed in time for the start of classes.



### Enrollment in subsequent years after the first

Transition from 1st to 2nd year

The transition from the first to the second year is subject to obtaining at least 30 ECTS credits (25 ECTS credits for part-time students) by the September exam of the year following enrollment. Therefore, students who enroll for the academic year 2024/2025 will be able to access the second year if they have obtained at least 30 ECTS credits (25 ECTS credits for part-time students) related to first-year exams by September 2025 (inclusive).

#### Transition from 2nd to 3rd year

For the transition from the second to the third year, passing all first-year exams and achieving at least 30 ECTS credits from the second year (18 ECTS credits for part-time students) by the September 2026 exam (inclusive) is required.

## METHODS FOR TRANSFERRING FROM OTHER STUDY PROGRAMS

In case of transfer from another University, or from another course of study, the Department, taking into account the specific educational objectives of the course of study and, in any case, respecting the educational constraints established by the current Educational Regulations of the course itself, ensures the recognition of the maximum number of CFUs already obtained by students. For the purpose of recognition, interviews or requests for verification tests may be carried out to assess the actual level of knowledge possessed.

In the case of transfer of students from one course of study to another, belonging to the same Classes L-18 or L-33 and characterized by substantial homogeneity of educational paths, the percentage of CFUs related to the same scientific-disciplinary sector directly recognized to students cannot be less than 50% of those already obtained. The evaluation, in each of the cases represented, is carried out by the Department's student practices Commission.

Some exams may be partially recognized; in this case, the student will be asked to complete the missing part of the program, subject to agreement with the teacher in charge of the course. The integrative exams can be taken, after enrollment by the student, only in the session dedicated to exams and not during the partial exam sessions. The Department considers CFUs acquired more than 10 years prior to the validation request to be obsolete, therefore in such cases it does not adopt recognition resolutions, nor verification systems and/or integrative exams.

## RULES FOR THE PRESENTATION OF STUDY PLANS AND INDIVIDUAL STUDY PLANS

Students must submit their study plan online in their third year to indicate their choice of optional courses, elective courses, and internship or alternative activities. Part-time students must submit their study plan online in their third year to indicate their choice of internship or alternative activities, and in their fourth year to indicate their choice of optional courses and elective courses.

The AIQUA Commission of the Degree Course will organize informational meetings to help students choose their optional and elective exams. Study plans that conform to the educational offer included in the ministerial database are automatically approved, following the procedure established by the Student Services Office Regulations.

Alternatively, students may submit an individual study plan (using the specific form provided by the Student Services Office), as long as it is consistent with their cultural project and appropriate to the educational objectives and specific contents of the Degree Course in Economics and Management of Innovation and Sustainability - Integrated Digital. The individual study plan, which must always comply with the minimum ECTS credits in the various disciplinary areas established by the educational regulations, is subject to approval by the course coordinator. If courses offered by the Master's Degree Programs in the Department of Economics are included, it is preferable that these are not designated as mandatory in the study plans of the respective Master's Degree Programs.

#### Extra teachings

If the student includes in the study plan additional teachings, in addition to those required to obtain the degree, they are considered extra. The credits obtained as a result of exams taken for additional teachings beyond those counted for the degree remain recorded in the student's academic record and may be subject to further recognition in accordance with current regulations. The grades obtained are not included in the calculation of the average grades of the examinations (Art. 20, paragraph 5 of the University Teaching Regulations).

In order to facilitate enrollment in master's degree programs, students enrolled in a study program can include in their study plan no more than two additional teachings beyond those required to obtain the degree. The credits and grades obtained for the additional teachings are not included in the calculation of the average grades of the exams but are recorded in the academic record (Art. 21 of the University Regulations for Students).
