<b>METHODS OF VERIFICATION OF KNOWLEDGE AND ADDITIONAL OBLIGATIONS (OFA)</b>	<p><b>Admission to the Master of Laws degree program</b> requires a high school diploma or other qualification obtained abroad and recognized as suitable.</p> <p>The Degree Course does not have numerical limitation of enrollment or entrance tests.</p> <p>However, students must take, at the beginning of their first year, a test described in the Entry Requirements section: (<a href="https://www.uninsubria.it/link-veloci/cerca-i-servizi/test-di-verifica-delle-conoscenze-didec">https://www.uninsubria.it/link-veloci/cerca-i-servizi/test-di-verifica-delle-conoscenze-didec</a>).</p> <p>The subject of the verification test is:</p> <ol style="list-style-type: none"> <li>basic language skills (logical-syntactic, textual, semantic-lexical, stylistic and sociolinguistic);</li> <li>skills related to Citizenship and Constitution and English Language basic level.</li> </ol> <p>Specifically, the test consists of 5 sections that include:</p> <ol style="list-style-type: none"> <li>Linguistic and word meaning comprehension (maximum score 8/30);</li> </ol>

The inclusion of simple and articulate prepositions in a text (maximum score 4/30);
- 3)  
the conjugation of verb tenses and modes (maximum score 12/30);

A multiple-choice question on skills related to Citizenship and Constitution (maximum score 3/30);
- 5)  
A multiple-choice question on English language skills - basic level (maximum score 3/30).

The test paper is graded in thirtieths and is considered passed upon reaching the minimum threshold of 18/30.

For those who do not meet the minimum required threshold, there are additional educational obligations (OFAs) consisting of a short self-study course organized by the Department.

The Italian language self-study course consists of 14 individual lessons, usable online, with intermediate and advanced levels of learning to be passed (grammar, vocabulary, listening). At the end of the course, the system certifies whether the self-study course has been passed and OFAs have been met.

Both the initial verification test and the self-study course can be repeated.

Failure to pass the verification test and the self-study course allows you to attend classes, but not to take the relevant profit exams. The profit exams can only be taken after passing the language proficiency test.

In order to pass the verification test, it is possible to ask for support from a tutor teacher of the LSC.

It should be noted that the University offers optional pre-courses in basic writing and English language that will help fill any gaps in logic-linguistic knowledge.

Exempted from taking the test are those who obtain career shortening due to transfer/passing/second degree/decadence/withdrawal following the recognition of at least one exam taken in their previous university career.

**For those who intend to pursue a Double Degree the University of Nantes (France), the following are required:**

- 1)  
French language proficiency at the B2 level and a good knowledge of English;
- 2)  
participation in a call for applications issued by the Office of International Relations at the beginning of each calendar year.

The annual selection of applicants is managed by the Department of Law Economics and Cultures. Admitted students will be included in the rankings of the university Erasmus call for applications (they will therefore have the status of Erasmus students) and will benefit from a scholarship on European and university funds. ## I. RULES ON THE TRAINING COURSE



### PROPAEDEUTICITY

For the purpose of admission to the profit examinations of the course of study, the student is required to comply with the following propaedeuticitities

Passing the Private Law and Constitutional Law exams is preparatory to any other **positive law** exams. **Positive law** exams are defined as the following subjects in addition to those related to the compulsory subjects of the 2nd year, including those of your choice from (*Ecclesiastical Law, Canon Law and Comparative Law of Religions, Sociology of Law, Legal Informatics, General Theory of Law, Comparative Private Law and Comparative Public Law*) and subsequent years:

  - International law and new technologies
  - International and European environmental law

  - Swiss Private Law
  - Public law of the sustainable economy
  - Swiss public law
- Fundamentals of legal translation
  - Administrative justice

#### **RECOGNITION OF LANGUAGE CERTIFICATIONS.**

English language certifications cannot be recognized as "Legal English" (mandatory teaching provided in the first year of the course at both locations).

Certifications in English and other foreign languages can be recognized as additional language skills, item (f), and are valid for three years. Regarding the number of CFUs, the following scheme applies:

- 4 CFUs will be recognized for B1 level certifications
- 6 CFUs will be recognized for B2 level certifications
- 7 CFUs will be recognized for C1 level certification
- 8 CFUs will be recognized for C2 level certifications

Examinations in generic English and other foreign languages, taken in other university courses - may be recognized only as additional language skills (f), maintaining the number of credits earned. The above exams are valid for 8 years.

#### **RECOGNITION OF PROFESSIONAL SKILLS OR EXAMINATIONS ACHIEVED IN PREVIOUS CAREERS.**

For the purposes of enrollment in the degree program and the accrual of educational credits, students may be credited with prior educational activities, in accordance with current regulations, as determined by the Departmental Council, as well as in accordance with the criteria set forth in the paragraph "Modalities for transferring from other courses of study."

#### **ATTENDANCE REQUIREMENTS.**

The Master of Laws degree program requires continuous attendance, the assessment of which is delegated to the course holder in accordance with methods and criteria defined in relation to the nature of the course.

Continuous attendance at classes, which allows constant dialogic interaction with lecturers, is definitely recommended with a view to full acquisition of content and methods of study, work and research.

#### **ENROLLMENT IN THE YEARS AFTER THE FIRST (ANY BARS)**

#### **ARRANGEMENTS FOR TRANSFER FROM OTHER COURSES OF STUDY**

The student coming from another University or from another course of study of this University, or from previous orders, may request transfer/passage to the Degree Course. Requests for transfer/pass will be considered by the Departmental Council, which will make an evaluation in this regard, possibly granting the student university credits. The evaluation will have to take into account the congruity of the scientific disciplinary areas and the contents of the educational activities, passed by the student in the previous career, with the specific educational objectives of the course of study and of the individual educational activities envisaged in the course of study.

Students who transfer to the degree program from another University and students who transfer to the degree program from another degree program and/or are already in possession of a previous career may be admitted, on the basis of the resolution of the competent structure, given the current Regulations governing such transitions, to years subsequent to the first, without prejudice to the impossibility of being admitted to non-activated years, based on the number of credits recognized to them in the degree program



in which they enroll- see table below-, subject to evaluation and subsequent validation of the exams taken. Career evaluation and/or total and/or partial recognition of the exams taken as well as enrollment in the relevant year will be decided by the competent structure and communicated to the student by the student secretary's office.

The student will be admitted to the

- 1st year of the course following the recognition of less than half of the credits in the 1st year;
- 2nd year of the course following the recognition of not less than half of the credits of the 1st year;
- 3rd year of the course following the recognition of not less than 3/4 of the credits of the 1st year + half of the credits of the 2nd year;
- 4th year of the course following recognition a number of credits corresponding to all credits of the 1st year of the course + 3/4 of the credits of the 2nd year + half of the credits of those of the 3rd year;
- 5th year following recognition a number of credits corresponding to all credits of the 1st and 2nd year + 3/4 of those of the 3rd year course + half of those of the 4th year course.

#### **RULES FOR SUBMISSION OF STUDY PLANS AND INDIVIDUAL STUDY PLANS**

The student:

- at the time of 2nd year enrollment, via online questionnaire, must express a preference for one of the three activated pathways;
- during the 2nd year, according to the procedures and deadlines provided by the Student Secretary's Office, must submit the individual study plan and make it final, confirming or changing the choice of pathway, and indicate optional subjects.

In particular, it will need to include:

- 40 total cfu (5 teachings chosen from "Related or Supplementary/C Educational Activities," each of 8 cfu);
- 12 cfu total ("Student's choice/D" teachings);
- one or more activities up to a total of 6 cfu for the subjects of (f).

#### **STUDENT'S CHOICE TEACHINGS LETTER D (12 CFU)**

#### **ADDITIONAL LANGUAGE SKILLS, COMPUTER AND INTERPERSONAL SKILLS, INTERNSHIPS AND OTHER (6 CFU)**

As part of the "Student's Choice Teachings," students will be able to choose, as early as the 2nd year, from:

- teachings offered in the Law School, where not already chosen, or in other Schools provided by the Department or the University, as long as they are consistent with one's educational path.

In the area of "Additional language skills, computer and interpersonal skills, internships and others," students will be able to choose, as early as the 2nd year, from:

- the courses offered in the Law School, where not already chosen, or in other Schools provided by the Department or the University;
- internships/internships;
- Participation in seminars offered as part of the Courses of Study provided by DiDEC;
- Participation in courses: Summer School, Winter School and/or other courses organized by the University of Insubria;
- among the activities activated by the Department and publicized annually in the Manifesto of Studies.

Teachings provided by nationally "scheduled" University Courses of Study may not be chosen.

**Students enrolled in the economics and business track who intend to continue on to the master's degree in economics**  
will be required to take the exams listed in the tables above.

#### **MODE OF ENROLLMENT IN THE INTERNATIONAL INTEGRATED EDUCATIONAL PATHWAY (DOUBLE DEGREE)**

A student interested in the Double Degree with the University of Nantes in his or her first year will have to participate in a call for applications that will normally be published at the beginning of each calendar year. The call for applications will be issued and administered by the Office of International Relations and the Department of Law Economics and Cultures, which will oversee the annual selection of five students.

Interested students will also be required to be proficient in French at the B2 level in addition to a good knowledge of English.

These students will be included in the rankings of the university Erasmus call for applications (they will therefore have the status of Erasmus students) and will benefit from a scholarship on European and university funds.

The dual degree pathway involves taking courses in France as follows:





- third year 1st and 2nd semester at the University of Nantes La Roche Sur Yon campus
- fifth year 1st semester at the Nantes site
- fifth year 2nd semester internship activities in France

The 5 selected students, with the submission of the study plan, will have to choose the language-international pathway and adhere to the articulation of studies required for obtaining the double title that will be specified in the announcement of Double Title.

### CONTINUATION OF STUDIES - MASTER'S DEGREE IN ECONOMICS, LAW AND BUSINESS FINANCE CURRICULUM "ECONOMICS AND BUSINESS LAW", PROVIDED BY THE DEPARTMENT OF ECONOMICS OF THE UNIVERSITY OF INSUBRIA STUDIES

Students who choose the **economics and business pathway** and intend to continue with the Master's Degree in Economics, Law and Business Finance, Curriculum "Economics and Business Law," provided by the Department of Economics of the University of Insubria, will be entitled to enter the second year of the aforementioned master's degree, provided they support the teachings related to: "Related or supplementary educational activities/C"; "Teachings of the student's choice/D"); subjects of letter f) duly indicated in the study plan.

### CHARACTERISTICS OF THE FINAL TEST

The final examination (20 CFU) consists of the written elaboration, under the guidance of a lecturer supervisor - and possible co-rapporteur - of a monographic thesis with a character of originality, in one of the subjects provided for by the didactic order of the Course of Studies and is carried out in oral form before a Degree Committee composed in accordance with the University Didactic Regulations (Article 29).

According to the deliberations of the Department of Law Economics and Cultures Council, undergraduates in Law will be awarded upon graduation investigation:

- 0.33 points for each honors earned in educational activities with a value of 6 CFU or more;
- One additional point to those who have completed the Erasmus study program;
- One additional point for completing the course of study within the legal duration of the course (5 years).

In addition, undergraduates enrolled in the CdS in Law - double degree program with the University of Nantes (France), who have completed two full years abroad, will be awarded:

- two additional points.

The judgment on the dissertation discussion can lead to an increase in grades, compared to the average, corresponding to:

- up to two points above the curricular average (sufficient), for papers that are merely compilative of existing doctrine and/or jurisprudence (for legal theses or dissertations) or merely reconnaissance of the state of the issue or related debate (for non-legal theses);
- up to four points, for methodologically well set and discussed papers (good);
- up to six points for papers that are complete, accurate in method and exposition and/or original in some cue or conclusion (very good).

However, the committee may evaluate any higher scores based on a report prepared by the lecturer argued on innovativeness, originality and complexity.

Within the framework of the Master of Laws degree program, the project 'Syn-Thesis: new paths of educational alliance for thesis writing' has also been launched, aimed at promoting the writing of experimental theses, based on innovative and original empirical or legal research, and expendable also as research products of the Department of Law, Economics and Culture. For the purpose of writing a dissertation under the Syn-Thesis project, the student is expected to follow a research path in close collaboration with the supervisor, open to cooperation with research institutes and entities outside the University, arriving at the formulation of a text not necessarily extensive but with original content, methodologically rigorous and therefore amenable to publication.

It is possible to carry out theses with an interdisciplinary character, involving correlators from disciplines including non-law disciplines.

In the path leading to the acquisition of the double degree with the University of Nantes (France), the correlation of a lecturer from that university will be required.



**DEGREE SESSION - CAREER ABBREVIATION (Art. 29 c.11)**

The University Teaching Regulations (Art. 29 c. 11) states that "a student may shorten the normal duration of his or her course of study by no more than one semester in the final year of the course. Such shortening shall not entail a reduction in tuition and university fees."

Since attendance must be acquired before taking the exams, students who wish to take advantage of this rule should:

- submit the request for career shortening at the same time as the fourth-year study plan, indicating the exams of the second semester of the fifth year to be brought forward, subject to compliance with propedeuticities

*or*

- submit the request for career abbreviation in the fifth year of the course if they do not have to take exams in the second semester. In this case, the deadline for submitting the request is the same as the deadline for submitting the study plan.

The method of submission of the study plan, graduation application and the method of payment of the tuition installment are indicated by the Student Secretary's Office according to the administrative deadlines set by the Academic Senate.
