project Description of the research project and the specific functions on which the post-doctoral contract holder will be engaged	The project focuses on the study and enhancement of the archaeological site of Qalaat el-Hosn (High Shouf, Lebanon) through stratigraphic excavations, documentation, artifact analysis, and reconstruction of the historical and environmental landscape in order to achieve the strategic objectives of the REVEAL project - which integrates biodiversity protection, territorial enhancement and archaeological research in the Shouf Biosphere Reserve (Lebanon). It provides for the scientific supervision of the archaeological and historical-artistic investigations necessary to reconstruct the transformations of the landscape from ancient times (5000 BC) to today, connecting the data with the environmental conservation and sustainable development actions coordinated by the University of Insubria (DiSTA), which provides complementary skills in wildlife management, territorial enhancement and environmental modeling. In addition, the project aims to read, contextualize and return the archaeological results as a founding basis for the integrated narrative of human-environment interactions, the very fulcrum of the UNESCO Reserve promotion project. The contractor is also required to comply with the following obligations: Drafting of periodic scientific reports to be shared with the University of Insubria, AICS and partners according to the AICS templates and application of the procedures provided; Contribution to the scientific and popular publications of the project; Risk management and site security, in coordination with local responsible partners; Monitoring compliance
Salary	with local regulations on archaeological and environmental protection.  The salary is in accordance with the provisions of the D.P.R. 15 <sup>th</sup> December 2011, n. 232 (Regulation for professors and researchers' salaries).  The salary for research contract amounts to € 39.224,28 per year, gross to the recipient.
Admission requirements	Candidates holding a PhD or equivalent qualification, obtained in Italy or abroad, or for sectors interested, Italian medical specialization, on the closing date for applications are eligible for selection.
	Candidates enrolled in the last year of a PhD course or the last year of Italian medical specialization course may also be admitted to the

selection, provided that the degree is expected to be obtained by the mandatory deadline of six months of the date of publication of the selection notice in the Official University Register, under penalty of forfeiture of the right to award the contract of research.

Candidates who find themselves in one or more of the following situations are excluded from participation in the selection procedure:

- 1. Those who are not entitled to exercise civil and political rights;
- 2. Those who have been dismissed or relieved from office with a Public Administration for consistently poor performance or declared lapsed for having obtained the appointment or hiring through the production of false or invalid documents or dismissed;
- 3. Those who have a tenured position at a university, public research institution or an institution whose scientific specialization diploma has been recognized as equivalent to a PhD, in accordance with art.74 of Italian Presidential Decree of July 11 1980, no.382;
- 4. Those who have a degree of kinship or affinity up to and including the fourth degree with a professor belonging to the Department proposing the activation of the contract or to the Rector, the General Director or a member of the Board of Governors of the University;
- 5. Those who have used fixed-term researcher contracts pursuant to Article 24 of Italian Law 240/2010;
- 6. Those who to exceed, with the two-year research contract referred to in this announcement, the maximum overall duration of 5 years, pursuant to art. 22, paragraph 2, of Law no. 240/2010, even if the contracts have been stipulated with different institutions.

This Administration guarantees fairness and equal opportunity to men and women in access to employment and employment conditions.

### Application for the selection procedure

- 5. that they have not been dismissed from office with a Public Administration for consistently poor performance nor from a civil service job in accordance with Art. 127, section (d) of Pres. Decree no. 3/1957;
- 6. domicile (address, phone number email or pec address) that they choose for the purposes of the application;
- 7. that they are not related by blood up to the "fourth degree of kinship" (as understood in Italian, e.g. up to cousins and cousins of the candidate's spouse) to the Rector, the university's Managing Director, a member of the university's Board of Governors or a Professor working at the Department that proposed the activation of the contract;

- 4. curriculum vitae, in Italian or English, duly dated and signed, which clearly shows the scientific-professional activity suitable for carrying out the research activity which is the object of the contract;
- 5. declaration in lieu of affidavit attached outline "annex A", duly dated and signed, which certifies that every information in the CV is true.
- 6. any further documentation to supplement the curriculum vitae deemed useful for the purposes of the evaluation (max. 30 MB);
- 7. publications in pdf format relevant for the selection procedure within the maximum limit provided for the position;
- 8. just in case of PhD awarded abroad, declaration of the "equivalence" with the Italian PhD; if not attach a copy of the qualification accompanied by a translation into Italian or English, the diploma supplement or the description of local value drawn up by the competent diplomatic or consular representation or the transcripts of the exams taken;
- 9. just in case of registering in the final year of PhD or the Italian medical specialization attach a certificate of enrollment showing the expected date of achievement of the qualification and the transcript of the exams taken.

For the PhD title obtained abroad, the judging committee will assess the equivalence of the degree acquired or in the process of being acquired, for the purposes of the procedure.

### Scientific Publications

Candidates must upload their publications in .pdf of the capacity of 30 MB each one. If your publication exceeds 30 MB, you can split it following the number order in your publications list (attached B) e.g. publication n. 1 – title – part n. 1 etc.

Published works not uploaded within the closing date shall not be taken into consideration by the Examining Board.

If a candidate presents more publications than required, the Examining Board will evaluate the publications them according to the order of insertion, up to the limit provided. For the purposes of this selection procedure only published works or texts accepted for publication as provided under current standards shall be accepted for evaluation, along with essays in anthologies and journal articles published in hard copy or digital format excluding internal notes or departmental reports. Publications must take into account the current legislation regarding editorial activity and copyright.

The doctoral thesis or equivalent qualifications are taken into consideration even in the absence of such conditions. If the candidate intends to present it, he/she must count it in the maximum limit of
