The biological data must be integrated with historical medical research, to contextualize the results and also to deepen knowledge of the techniques and materials used in the petrification process.</p> <p>Collaboration in teaching activities: The successful candidate will contribute to teaching activities by delivering seminars and thematic lectures within the History of Medicine courses, as well as participating in the elective activities offered annually</p> <p>Collaboration in the public engagement activities: The successful candidate will contribute to the project's Third Mission activities, including public outreach events to disseminate research findings and scientific events.</p>

Scientific Publications	<p>Candidates must upload their publications in .pdf of the capacity of 30 MB each one. If your publication exceeds 30 MB, you can split it (e.g. -publication n. 1 title – part n. 1 - publication n. 1 title – part n. 2 etc).</p> <p>Published works not uploaded within the closing date shall not be taken into consideration by the Examining Board.</p> <p>If a candidate presents more publications than required, the Examining Board will evaluate the publications them according to the order of insertion, up to the limit provided.</p> <p>For the purposes of this selection procedure only published works or texts accepted for publication as provided under current standards shall be accepted for evaluation, along with essays in anthologies and journal articles published in hard copy or digital format excluding internal notes or departmental reports. Publications must take into account the current legislation regarding editorial activity and copyright.</p>



	<p>The doctoral thesis or equivalent qualifications are taken into consideration even in the absence of such conditions. If the candidate intends to present it, he/she must count it in the maximum limit of publications, where provided for in Annex 1a for the procedure in which he/she intends to participate. Publications must be edited in Italian, French, English, German and Spanish. In case of procedures in linguistic subjects, it is also admitted the relative language mentioned in the announcement.</p> <p>The University can carry out controls and ask for the original papers and publications.</p> <p>It is the candidate's responsibility to ensure, before completing the application, that all qualifications and publications have been uploaded by checking the "Attachments" section of the PICA online procedure.</p>
Exclusion from the competition	<p>Candidates are conditionally admitted to the selection procedure. The exclusion, due to lack of the requirements on the expiry date, can be ordered at any time. The exclusion is ordered by motivated Rector's decree and is notified to the person concerned.</p>
